

YOU HAVE CHOSEN TO APPLY FOR RESIDENCY WITH MOSES LAKE REALTY GROUP

Moses Lake Realty Group requires a tenant screening report that may include: a scored credit report, address history, criminal history search, sex offender registries search, eviction history search, residence history verification, employment verification, and/or driver's license verification.

IMPORTANT: Once the primary applicant's information has been processed and approved, an email will be sent to all other persons who will be living at the address (spouse, roommate, etc.) Each additional resident MUST respond to the email, supply the requested information and "electronically" sign these separate applications.

As part of your application for residency with Moses Lake Realty Group you need to fill out the following application so that we can conduct a background report. The application takes approximately 20 minutes to complete. Please be sure to answer all questions and include the most current and up-to-date contact information.

INCOMPLETE APPLICATIONS MAY CAUSE SERIOUS DELAYS AND/OR DENIAL

A background screening specialist from ACRANET may contact you for additional information during the screening process. Please respond promptly so the background report can be completed as quickly as possible so as not to delay the approval process. An order summary page will confirm the information that you have submitted allowing you to review your order and make any necessary changes. Please be careful to double check all the information you provide. Once you place the order, you will not be able to modify or change it. You will also be required to pay an application fee before submission of the application is complete. **THE APPLICATION FEE IS NON-REFUNDABLE.**

RENTAL CRITERIA

THE FOLLOWING WILL RESULT IN A DENIAL

- 1. Delinquent accounts on the credit report (more than 10% of total number of accounts are delinquent)
- 2. Collections and/or charge offs from the credit report (more than 10% of the total number of accounts are in collection or charged off)
- 3. Bankruptcy listed on the credit report filed in the last three years
- 4. Any currently pending criminal charges
- 5. Any Convictions on Crimes against a person and/or property, Drug manufacturing and/or drugs that adversely affect others around, Registered Sex Offenders within the last 7 years
- 6. Two or more misdemeanor convictions in the last seven years
- 7. Registered sex offender
- 8. Any eviction record
- Negative rental history such as excessive noise complaints, outstanding debts and payment problems, extensive damages, or anything that would cause a landlord to not re-rent. Mortgage history with more than 6 late payments in the last two years will also be denied.
- 10. Falsification of information provided on rental application

ANY APPLICATION THAT DOES NOT RESULT IN A DENIAL WILL RESULT IN A CONDITIONAL APPROVAL OR STRAIGHT APPROVAL. CONDITIONAL APPROVAL MAY INCLUDE ONE OF THE FOLLOWING:

- 1. Approval with first and last months rent required
- 2. Approval with an increased deposit
- 3. Approval with a qualified roommate
- 4. Approval with a co-signer

In the event of a denial or other adverse action you have the right to obtain a free copy of the consumer report and to dispute the accuracy of the information appearing in th consumer report.
